\* Junior Membership fee applies to those 16 to 18. For Juniors under 16 years old, membership is free, however, an adult member guardian MUST be present during flight.

\*\* NWRCC requires members to attend 2 work crew days per year. Those who have a physical handicap or medical condition preventing them from working outside may elect to provide alternate support for the club such as printing and delivery of flyers, weed eater repair, or other non physical jobs. Only those who have approval from the executive board can be exempt from all work with no penalty. Please see reverse side of this application to request exemption.

NWRCC membership runs from Jan 1 to Dec 31 each year. The dues portion of an adult membership fee is prorated at a rate of \$20 per month after August 1st. The one time initiation fee IS NOT pro-rated

As in all organizations, NWRCC has it's own rules and regulations that are for the benefit of all. All members, both new and renew, are asked to read and acknowledge the following paragraphs which outline individual members basic responsibilities within Northwest Houston R.C.

1. I agree to abide by and enforce the Academy of Model Aeronautics ( AMA) National Safety code for all model airplane operations

2. I will read and understand the Club's constitution, bylaws and rules and agree to abide by them or accept the consequences for failure to do so.

3. I understand that my membership in the Club requires, in addition to initiation fees and annual dues, that I perform supervised maintenance duties at the flying field for at least two - three hour sessions per calendar year. If I am physically unable to work outside, I will perform other non-physical duties in support of the Club as defined by the Club officers. Furthermore, I understand that my failure to fulfill my yearly obligations can lead to an assessment of \$125.00 or expulsion from the club.

I request an exemption from all work due to my current physical state ( must be approved by NWRCC officers)

4. I understand that the rules for invited guest pilots to fly on the club field includes:  
 A. All flying guests must be invited by and supervised by a club member  
 B. All flying guests must have with him, a current AMA membership card  
 C. Guests are allowed to fly a maximum of 3 visits. After 3 visits, guests must join the club as noted in the Club constitution and bylaws.

**Waiver of Liability**

I understand that I am about to enter upon private property operated by Northwest Houston Radio Control Club as a flying field for radio controlled aircraft. I further understand that I must follow and obey NWRCC club safety rules. I further understand that there are potential dangers in the operation of radio controlled model aircraft that may cause me injury or damage my property. By entering onto this land, I waiver any claim I may have against NWR/C Club for any personal injury or property damage that I may receive while on this land. This waiver shall also apply to any claims for my injury by my heirs, I, My Estate, or my guardian, or conservator. I further certify that I will not participate in model operation activities unless I am a current member of the **Association of Model Aeronautics**

Note: NWR/C Club is a member Club of the American Modeling Association and as such is covered by A.M.A. liability insurance.
